

WEDDING CONTRACT

This agreement contains the entire understanding between the PHOTOGRAPHER (Thomas Craig for TRC Photo) and the undersigned, hereafter named as the CLIENT. The client hereby contracts the photographer to provide photographic services as stipulated in the attached documents on July 2, 2010.

It is agreed that the sum of \$_____ will be paid upon signing of this contract. Upon receipt of both contract and deposit, the photographer agrees to reserve the date specified above, and will not make another reservation for the specific time frame. For this reason, retainer fees are non-refundable. The client agrees to pay the balance of \$_____ due and payable in full to Thomas Craig, no later than _____, 2010. Failure to produce payment by this date will deem this contract null and void, with no further obligation on the part of the photographer.

Simultaneous photographic coverage by any other photographer, professional or consumer shall release the photographer from this agreement. Should such an event occur, fees shall be retained by the photographer. In addition, it is requested that guests and family members do not take pictures of setup and posed shots, as doing so will delay the photographic process, and adversely impact the photographs. The photographer will not be held responsible for the final results of any photographs taken with such interference during the photographic process.

Every effort will be made to ensure the stipulations agreed upon within this contract will be met or surpassed by the photographer. However, in the unlikely event that the photographer is unable to complete her contracted obligation due to circumstances beyond her control (act of God, equipment malfunction, grave illness, etc.), the liability of the photographer is limited to all payments received for the event package, and the photographer shall have no further liability with respect to this agreement.

The photographer asks that reasonable accommodation be provided for the photographer and one assistant for meals when photographic coverage is scheduled to continue through the reception. They request that such meals be timed with the guests' main course, so that no photo opportunities are missed.

Although every reasonable effort will be made, photographing a specific moment is not guaranteed by the photographer, and she will not be held responsible for any missed moments. It is understood that the photographer is limited by the guidelines of the ceremony official or reception site management, and the client agrees to accept the technical results of such an imposition upon the photographer. Negotiation with such officials for moderation of such guidelines is understood to be the responsibility of the client.

The client shall attempt to provide the photographer with adequate time to perform the photo shoot portion of the day's events to accommodate family and bride and groom portraits. The photographer recommends a period of at least one hour to complete these photos. The photographer cannot be held responsible for timelines that do not run on

schedule and subsequently reduce the time allotted for photos, thereby not providing the client with all the photos expected. The photographer will not be held responsible for photos not completed due to the possibly uncooperative nature of the individual to be included in the photographs. It is the client's responsibility to inform all participating parties where and when the photographs will be taken.

The clients hereby recognize the copyright of all photographs together with the right of reproduction either wholly or in part, are and will remain the property of the photographer. The clients agree that the photographer, licensees or assignees may use the photographs either separately or together, either wholly or in part, in any way, and in any medium. It is understood that the photographer has unrestricted use of any and all photographs, for whatever purpose, including advertising, with any reasonable retouching or alteration. Additionally, the clients waive any right to royalties or other compensation arising or related to the use of the photographs.

TRC Photo will provide photography for the hours of _____
_____. TRC Photo will provide a copy of the images on CD within 1 month of the wedding. The images provided may be used for any and all personal reasons, but may not be used for financial gain.

NOTICE OF COPYRIGHT - It is ILLEGAL to copy or reproduce these photographs without the written permission of the photographer. Violators of this Federal law will be subject to its civil and criminal penalties. Permission is granted by the photographer for personal use only.

The undersigned hereby warrant that they are competent to contract in their own name. They hereby confirm that they have read the above agreement, and are familiar with the contents therein. In signing this contract, all the undersigned agree to all terms and conditions stated in said contract, as this agreement shall be binding upon us, our heirs, legal representatives, and assigns. Any modifications of this contract must be in writing, signed, and approved by all the undersigned.

Payment of Deposit will be considered as agreement to this contract.
